**Subject :-** Continuation of recognition of Siksha Bhavan Mantessori School, Dharmanagar,  
North Tripura up to class VIII for a period of 3 (three) years w. e. f – 01/03/2019.

Dear Madam,

In response to your application dt.10.03.2019 for continuation of recognition in favour of Siksha Bhavan Mantessori School, Dharmanagar, your reply dated 14/3/2019 in response to this office memo No.F.3(29)/DEO(N)/DMN/GNL/2013/17598 – 99, dated, Dharmanagar the,13<sup>th</sup> March, 2019 has been scrutinised at this end and the **Siksha Bhavan Mantessori School is hereby accorded recognition to continue classes up to class – VIII for a period of 3 (three) years w. e. f – 01/03/2019** subject to compliance of rules & regulations issued by the School Education Department.

**The above sanction is subject to fulfilment of following conditions:-**

- 1.The grant for recognition does not in any way imply any obligation to recognize / affiliation beyond Class VIII.
- 2.The School shall abide by the provisions of Right of Children to Free and Compulsory Education Act, 2009 (Annexure I) and the Right of Children to Free and Compulsory Education Rules (Tripura), 2011 (Annexure II).
- 3.The School shall admit in class I, to the extent of 25 % of the strength of that class, children belonging to weaker section and disadvantaged group in the neighbourhood and provide free and compulsory elementary education till its completion.
- 4.For the Children referred to in paragraph 3, the school shall be reimbursed as per Section 12 (2) of the Act. To receive such reimbursements school shall provide a separate bank account.
- 5.The Society / School shall not collect any capitation fee and subject the child or his or her parents or guardians to any screening procedure.
- 6.The School shall not deny admission to any child for lack of age proof Certificate .If such admission is sought subsequent to the extended provided prescribed for admission. On the ground of religion, caste or race, place of birth or any of them.
- 7.One representative of the School Education Department shall have to be included in the School Management Committee.

**8.The School shall ensure:**

- i) No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school.
- ii) No child shall be subject to physical punishment or mental harassment.
- iii) No child is required to pass any board examination till the completion of elementary education.
- iv) Every child completing elementary education shall be awarded a certificate as laid down under Rule 9 of RTE Act – 2009.
- v) Inclusion of students with disabilities / special needs as per provision of the RTE Act.
- vi) The teachers are recruited with minimum qualification as laid under section 23 (1) of the RTE Act – 2009. Provided further that every teacher appointed or in position as on date, Who does not possess minimum qualifications as laid down under subsection (1) of section 23 shall acquire such minimum qualification within 31<sup>st</sup> March, 2019 as per RTE (Amendment) Act, 2017 of RTE Act, 2009.
- vii) The teacher performs its duties specified under section 24 (1) of the Act and
- viii) Teachers shall not engage himself or herself for private teaching activities.

- 9.The School shall follow the syllabus on the basis of curriculum laid down by appropriate authority.

10.The School shall enrol students proportionate to the facilities available in the school as prescribed in the section 19 of the Act.

11.The School shall maintain the standards and norms of the school as specified in section 19 of the Act. The facilities reported at the time of last inspection are as given under :-

- a)Area of school campus:- 7575. 67 Sq. Mtrs.
- b)Total built up area : 2283 Sq. Mtrs
- c)Area of play ground :- Yes.
- d)No. of class rooms :- 15 nos. room.
- e)Room for Headmaster – cum- Office –cum- Storeroom :-4 nos. room.
- f)Separate toilet for boys and girls :- 8 no. for Boys, 8 no. for Girls.
- g)Drinking Water Facility :- Pure it-Water Purifier.
- h)Kitchen for cooking :-No.
- i)Barrier free Access :- Yes.
- j)Availability of Teaching Learning Material / Play Sports Equipments / Library:-Yes

12.No Unrecognized classes shall run within the premises of the school or outside in the same name of school.

13.The school buildings or other structures or the grounds are not used during the day or night for commercial or residential purposes (except for the purpose of residence of any employee of the school) or for political or non- educational activity of any kind whatsoever;

14.The School is run by a society registered under the Societies Registration Act, 1860 (21of 1860) , or a public trust constituted under any law for the time being in force ;

15.The School is not run for profit to any individual, group or association of individuals or any other persons;

16.The accounts should be audited and certified by a Chartered Accountant and proper accounts statements should be prepared as per rules. A copy each of the Statements of Accounts should be sent to the DEO every year.

17.The recognition Code Number allotted to your school is N/2019/UP.(O)/59 . This may please be noted and quoted for any correspondence with this office .

18.The School furnishes such reports and information as may be required by the Director of Elementary Education / District Education Officer from time to time and complies with such instructions of the State Government / Local Authority as may be issued to secure the continued fulfilment of the condition of recognition or the removal of deficiencies in working of the school.

19.Renewal of Registration of Society if any, be ensured.
