
1. 10 days suspension will be imposed against the student.

3. If any student repeats such activity after completion of his / her suspension period then school authority will issue Transfer Certificate against him / her without any further discussion with parent.


So, you are requested to closely observe your ward's activity particularly while he / she is using your mobile phone at your house.


You are also requested to uninstall "Fampay" app (Photo of the app is given below) from your mobile if your ward has already installed it.
